**Notice:** I'll cover several issues at this time.

1. I demand your bona fides to occupy the position you have, Billy J. Williams did not comply with governing law and he was found to be in error by our Grand Jury. A Presentment will be forthcoming.
2. I spoke to you once. It was about the telecommunications staff you had that blocked my calls from a particular number. I either communicate with DOJ thru Seth or "YOU" will preclude me from communications. I challenge your authority. Prove it.
