Either self correct to the de jure Article VII (Original) or be tried in our de jure Civilian court of record with a True Bill from our Grand Jury.

Returning to a de jure government after more than 100 years of deceit due to Article VII (Amended) is difficult and we put for our best effort. Article I. Section1: Natural rights inherent in people. 
