#### Notice: A CLAIM OF CONUSANCE

This is from our de jure Civilian Court of record an Article III one supreme Court claiming original jurisdiction found in our Amendment VII Common Law Court of record without appeal in law, ARTICLE VII (Original).

To: Shemia Fagan, Secretary of State; Martha L. Walters and all Justices on the Supreme Court for the State of Oregon aka STATE OF OREGON, a subdivision of THE UNITED STATES, INC., in some form. 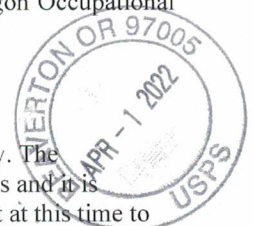
Assigned reading is the Battle of Athens, Tennessee, and the Georgia Guidestones.

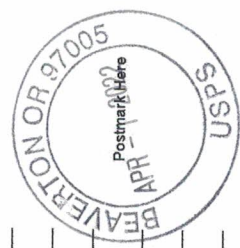
