



Evidential Explanation

On July ninth, 2024 A.D., 8 members of our Civilian Common Law Court of record made significant efforts to deliver a Writ of Habeas Corpus ad subjiciendum to the Director of Corrections, Mike Reese, at his office; our contingent then traveled to OSP to deliver the same document. The purpose was to extricate David Anthony Colage back into his proper jurisdiction and to our Court for a lawful Grand Jury hearing with complete evidence – not parsed and skewed as in the de facto Grand Jury and fraudulent trial, rife with unlawful and illegitimate procedures and processes. All the while David Colage was trespassed, jailed, ankle-monitored for months while lawfully pleading his innocence and that he was the victim of a crime, -- NOT the criminal, as falsely alleged. There was no acceptance of the credulity of our Court, nor the Writ. Our Court further demanded immediate medical attention for Dave due to their ignoring a cancerous growth on his neck and he has been denied proper care, to date.

On July 24th, 2024 A.D., -- two weeks later -- 6 members of our Civilian Court of record made a second trip to both locations to deliver, i.e., serve, a Writ of Mandamus to the same parties for failure to respond appropriately to the Writ of Habeas Corpus and to the veracity of our ARTICLE III, Amendment VII Civilian Court of record for which there is no appeal in fact.

The only response we received from the Oregon Department of Corrections was a letter acknowledging that our calls and emails (informing them of our intention to return with a Writ of Mandamus) would be fruitless; that we should mail or email our documents and that we would NOT be met by a staff person or by phone.

The purpose of a Writ of Mandamus is an order by a Court to a lesser government official(s) to perform an act required by law, which they have refused or neglected to do; and it commands them to refrain from performing an act the law forbids them from doing.

The keeper of the keys, that is, the bailee (for the building), and the jailor (for the man), must be notified of this release.

Your failure to produce our living, breathing, flesh-blood-mind-body-soul-spirit man has commenced this document and notice of intent to hold a Grand Jury from our jury pool with ensuing appropriate actions, notices and -- if a True Bill, a Petit Jury Trial will ensue.
