Notice of Arraignment: Grand Jury decision on August 26, 2024 determined that an Arraignment & Petit Jury Trial be held at 10 AM on Monday, September 23<sup>rd</sup>, 2024, @ 3723 Fairview Industrial Dr. SE, Salem, Oregon [97302]

for Cause No.08262024-GJ Ballot1-ODOC Arraignment, Trial

True Bill: This addresses the termination of lawful, legal, anything statutorily, and any remuneration of Michael Reese, Ken Jeske, Corey Fhuere of the Oregon Department of Corrections in any form. The three above-named men refused our Court's Writ of Habeas Corpus ad subjiciendum for the release of David Anthony Colage, a man, on July 9, 2024. This was in effect until July 24, 2024, -- still without the release of David. On the 24<sup>th</sup> of July the same three men were served with A Writ of Mandamus. That was also refused. To date, after proper service was read and the Writ of Mandamus accepted twice, David Colage remains in your custody, not that of our Court. You three above-named men, had the keys and a lawful Writ and refused. You have no honor and may not hold a position of trust.

In common law, if you three are "no shows" for your Arraignment, a Petit Trial will commence immediately.

Notice of Due Process by our de jure Article III Amendment VII Civilian common law Court of record: a "no show" at your Arraignment, causes this to be tried -- a Caveat to Will -- and you are guilty of violating due process of our Court in the form of Cynthia Palmatier, Anne Byer, Brandon Wingerter, and Ron Vrooman -- four people on Oregon in Original Jurisdiction. The penalty for 18 USC 3571 is 250,000 FRN per violation. We count 12 times two Writs or 24 times 250K. Due process was also denied David Anthony Colage 6 times at the same penalty; or something better if our jury is so inclined in equity.

A guilty vote by this jury will cause this to be filed with Oregon DAS Risk Management Director Shelly Hoffman to collect the penalty as directed by our jury whose verdict in matter of \$20 or more has no appeal in fact.
