Just In Case Law:

Case Law, Codes and Travel

Oregon Vehicle Code § 801.305 "Highway" means every public way, road, street, thoroughfare and place, including bridges, viaducts and other structures within the boundaries of this state, open, used or intended for use of the general public, for vehicles or vehicular traffic, as a matter of right.

The people have a prerequisite to exercise of right...may ignore the law and engage with impunity in exercise of such right."

In the Supreme Court Ruling, Miller vs. U.S., 230 F.486, 489, "The claim and exercise of a constitutional Right cannot be converted into a crime."

In another case, Shuttlesworth v. City of Birmingham, Alabama, 373 U.S. 262 (1963): "If the State converts a right (liberty) into a privilege, the citizen can ignore the license and fee and engage in the right (liberty) with impunity."

19 Cal.Jur. 54 S 407: "The streets of a city belong to the people of the state, and the use thereof is an inalienable right of every citizen...."

In Hertado v. California, 110 US 516, the U.S. Supreme Court states very plainly: "The state cannot diminish right of the people"

Bouvier's Law Dictionary, 1914, p. 2961: "Those who have the right to do something cannot be licensed for what they already have right to do as such license would be meaningless."

Editor's Note: One of the primary issues Oregon Statewide Jural Assembly and our ARTICLE III, Amendment VII common law Civilian Court of record continually addresses is that of our de jure position of our unalienable rights provided by the Laws of Nature and of Nature's God.

It is notable that here, even some entities clearly in the de facto, find it unlawful and unacceptable that people should be restricted from exercising their birth-right rights. For example, the idea of "driving is a privilege, not a right" is contended by many in law enforcement. Some of our members are making efforts continually on behalf of fellow Oregonians to exercise their rights to not comply with statutes and ordinances that not only are fraudulent, but contradict The United States of America's Constitution circa 1859.

Defining Words: "de jure" and "de facto"

De facto /dee-fak-tow/

In fact, indeed, actually. This phrase is used to characterize an officer, a government, a past action, or a state of affairs, which must be accepted for all practical purposes, but is illegal or illegitimate. Thus, an office, position or status existing under claim or color of right, such as a de facto corporation. In this sense, it is the contrary to **de jure**, which means rightful, legitimate, just, or Constitutional. (Black's Law 6th ed., p.416)

De jure, /dee-joor-ee/

Descriptive of a condition of which there has been total compliance with all requirements of law. Of right; legitimate; lawful; by right and just title. In this sense it is contrary to de facto. (Black's Law 6th ed., p.425)

Editor's Note: These are two different and disparate jurisdictions. The de facto, color of law, admiralty judicial system, corporate governance believes it has authority over the sovereign de jure jurisdiction of the people on the land and soil. The latter is the original jurisdiction established in The United States of America's Constitution circa 1859;

However, you can become a successful researcher by defining your question, creating a plan, utilizing a variety of sources, learning efficient search strategies, evaluating your sources, keeping track of references, taking good notes, and analyzing data. The most crucial advice is to always be curious and to keep learning. Enjoy your research! It can be incredibly exciting, rewarding and enjoyable!

Start broad, then dive into the specifics. Researching is a big task, so it can be overwhelming to know where to start—there is nothing wrong with a basic internet search to get you started. Online resources like Google and Wikipedia, while not always accurate, are a great way to orient yourself in a topic, since they usually give a basic overview with a brief history and any key points. Utilize other platforms to do the research.

Learn how to recognize a quality source. Not every source is reliable, so it is crucial that you can recognize the good sources from the not-so-good ones. To determine a reliable source, you will need to use your analytical skills and critical thinking and ask yourself the following questions: Does this source agree with other sources I have found?

Verify information from several sources. The internet is a big place, and, for the most part, anyone can say whatever they want online—many websites do not evaluate their content for factual accuracy. This means that there are plenty of unreliable resources out there, and even many that are outright incorrect. The best way to combat this is to make sure that whatever you find in your research, several different sources can verify that it is true. Rather than going with one webpage, make sure that at least two other places say something similar.

Be open to surprising answers. Good research is all about finding answers to your research questions. Solely looking for confirmation is a very limiting research strategy, since it involves picking and choosing what information to collect and prevents you from developing the most accurate understanding of the topic. When you conduct research, make sure to keep an open mind so that you can learn as deeply as possible.

Stay organized. During the data collection process, you will most likely be seeing a huge amount of information, from webpages to PDFs to videos. It is vital that you keep all this information organized in some way to prevent yourself from losing something or not being able to cite something properly. There are plenty of ways to keep your research project organized.

Take advantage of library resources. If you still have questions about researching, do not worry—there are plenty of places out there to help you out, even if you're not a student doing academic or course-related research. In fact, many high school and university libraries offer resources not only for faculty members' and students' research but for the larger community. Be sure to check out library websites for research guides or access to specific databases.

Constitution Cons:

A Paradox

It was there in the Constitutions of every state from 1819 to 1859 when Oregon became a state. However, allegedly, attorneys in the Lincoln Administration wrote a new Amendment 13 and methodically began to erase 13 TONA from history.

Editor's Note: Since then and to this day, we have large numbers of BAR attorneys, aka Esquires (a nobility title) and Doctors of Juris Prudence (JD's) in government positions who should not be. These entities have been taught and are practicing Admiralty and Commerce law -- not American common law -- and thus, should be registered with the Foreign Agents Registry Act (FARA). By our inquiring on Washington County as to an ARTICLE VII (Original) court, we have found the county seems to have “merged” them into one building and one law form, thus seemingly eliminating a de jure common law court with its original jurisdiction. 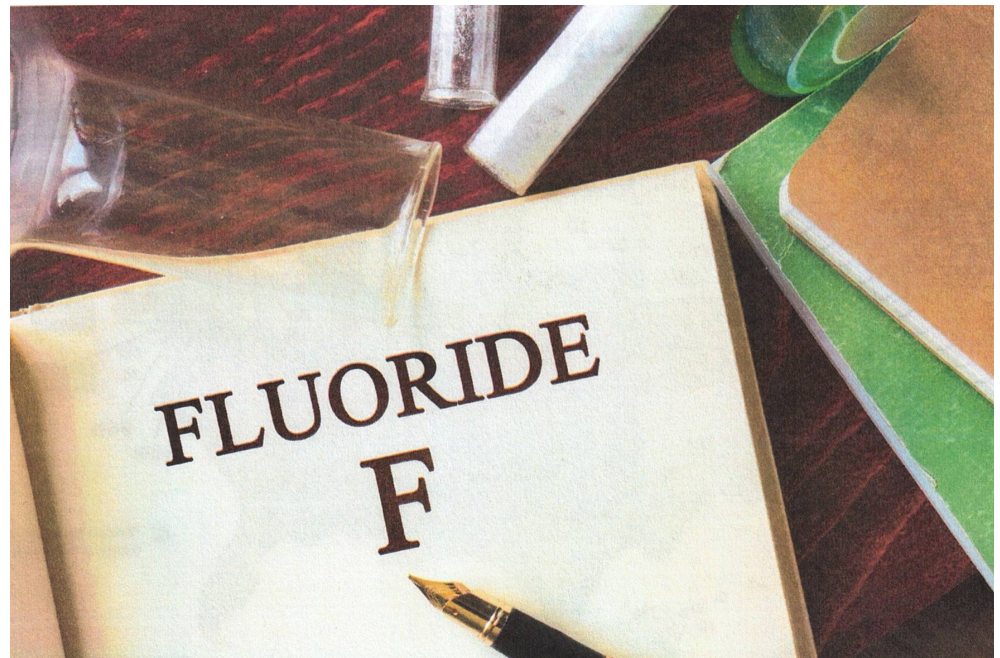

Extremely Important Update on Water Fluoridation – Part 1 of 3

Anyone who's been paying attention is aware of fluoride being an **extremely toxic** compound that is put into water, foods, toothpastes, etc. Of municipalities who fluoridate their water, 95% use **silicofluorides**, in particular **hexafluorosilicic acid**, an inorganic compound with the chemical formula H_2SiF_6 . This chemical, along with sodium fluoride (NaF), are the waste products of the processing of aluminum, phosphate, and uranium mining, which means they are contaminated with heavy metals, uranium, and such.

Most people are unaware of their water being fluoridated, and even fewer still understand the toxic effects of fluoride. Evidence to date demonstrates that fluoride does little, if anything, to prevent dental caries, though fluoride has been linked to numerous medical concerns.

No one has any idea how much fluoride they ingest daily gastrointestinally, or how much they absorb via their skin and respiratory systems when they bathe.

We now have three meta-analysis studies that demonstrate IQs being lowered 7-10 points as a result of fluoride exposure. The first one was from China in 2012, then Harvard in 2016, and finally DHHS' National Toxicology Program's 2023 report. In addition, the public is given absolutely **no informed consent** regarding fluoride, or any other additive to their potable water. Let's say you have some degree of kidney failure. Most folks with renal disease don't know they are not supposed to be exposed to fluoride. Unfortunately, fluoride can bioaccumulate to toxic levels in the blood stream as a result of the kidneys not being capable of properly filtering it. Same holds true for avoiding sodium and potassium in renal failure patients of any severity. **Why is the public not being given informed consent, especially when hooking up to a municipal water system?**

If you have a water fluoridation program in your town, this is the time to hit the City Council hard and frequently regarding the dangers of water fluoridation and requesting the immediate cessation of adding it to your water. If RFK, Jr. becomes the director of DHHS, which I assume he will, there will be a push by the Trump administration to remove fluoride from all potable water.

There is tremendous freedom in observing how my solar system works every day, how much power a day offers me and how I can manage that resource. The same goes for catching rain, storing it, keeping it clean and safe, and learning how to do things like dishes without wasting water.

Raising chickens for eggs is actually a lot of fun. I eat and preserve lots of eggs, feed the chickens with garden greens and kitchen scraps, and give them lots of opportunities to hunt for bugs. I’m learning how to care for rabbits, and plan to collect meat from them soon. Goats will be my next project in the spring, and I hope to eventually get milk and meat from that, as well as using the goats to help me clear my land of underbrush and poison oak.

Of course, a lot of work revolves around gardening: planning, planting, watering, and harvesting and preserving my crops. My best advice about that is, only grow what you like to eat!
