

## **Petit Trial Verdict: Risk Management Award**

### **Notice to Principal is notice to Agent. Notice to Agent is notice to Principal.**

Re: A 3rd party intervention by a clerk from a higher Court, the one supreme Court on Oregon Article III Amendment VII Civilian common law Court of record claiming original jurisdiction with ARTICLE VII. Aka ARTICLE I Section 1, our Oregon Statewide Jural Assembly in social compact.

Award: Two hundred fifty thousand dollars (250K) to Anthony Gerome Devine to be paid by the risk management DAS enterprise whose agent is known as Shelley Hoffman. To be paid by deposit into the accounts on Oregon provided to DAS by Anthony Gerome Devine no later than 30 days from this date: 04/04/2025.

All bona fides were in order as named and called for their vote. They are Bill, William, Cynthia, Laura, Anne, Catherine, Sam, Brandon, Phil, Thomas, Gary and Rod.

In common law our Court determines the law and our jury determines the facts. (Bouvier, 1856).

Therefore:  
We tried this due process before when Tobias was in Treasury. The verdict was 18 USC 3571 which set the standard at this level. Each violation is valued at two hundred fifty thousand dollars (\$250K). Tony is filing one due process violation against patrolman Andrew Tuttle at OSP.

Declaration of fact: Anthony Gerome Devine is not in the de facto jurisdiction and a Claim of Conusance is on this claim filed and a copy is available. In this and many other matters of the state v one of us on the land and soil jurisdiction the de facto has no authority. 
